3. Method of Citation: ILI Method of Citation with footnoting.
4. Paper Size: A4 with 1 inch indent on all four sides, Font size 12 Times New Roman, Justified (10 Times New Roman for footnotes), 1.5 line spacing.
5. All papers must include an abstract of not more than 300 words.
6. Selected Papers will be published in the form of a book (Paper presenters must give a self certificate of authenticity, compliance with plagiarism not being more than 20% and with due credit to the sources, and that it has not been published anywhere else. Further, the paper presenters must allow modification to the text of the paper by the editors of the book.)
